

## **City of Hughson Firework Permit Application**

On the 14th of January 2019, the City Council of the City of Hughson passed and adopted Ordinance 2018-05 creating Chapter 8.18 - Fireworks of the Hughson Municipal Code.

Application and required fees deadline:

- Firework stands must be submitted to the Finance/Administrative Services Department by 5:00 p.m. on June 15th.
- Firework displays must be submitted to the Finance/Administrative Services Department no later than fourteen (14) days prior to the scheduled date of the display.

Permit fees are as followed:

- Retail sales of "safe and sane" fireworks is \$85.
- Fireworks displays is \$200. This fee is non-refundable and is in addition to the permit fee for retail sales and any other fee or tax imposed.

Permits will be issued after an inspection of the place of storage and stand reveals compliance with all conditions of Ordinance 2018-05.

One representative from each organization must attend a stand operator safety seminar conducted by the Fire Department and the firework industry. Failure to attend will result in the revocation of the organizations permit and license to sell fireworks for that calendar year. Dates and time of seminar will be given at time of application.

Sale of fireworks within the City shall be limited to the period commencing on June 28th and ending on July 6th for the hours of operation, also in which all unsold fireworks should be removed by 5:00 p.m. Stands shall not be set up before June 14th and shall be removed by 12:00 noon on July 12th. Any stand not removed at this time will be charged an additional fee of One Hundred and no/100ths (\$100.00) Dollars per day.

Completion of the Stanislaus County Fire Prevention Bureau Application for Permit to Sell Safe and Sane Fireworks must be completed prior to and included with the permit application. Can be obtained through the county:
